GRANT OF SHARE OPTIONS PURSUANT TO SHARE OPTION SCHEME

This announcement is made pursuant to Rule 17.06A of the Listing Rules.

On 20 April 2018, a total of 801,283 share options (the “**Share Options**”) to subscribe for 801,283 Shares were granted to a total of 28 eligible persons (the “**Grantees**”) under the Share Option Scheme, subject to acceptance of the Grantees.

Each Share Option shall entitle the holder of the Share Option to subscribe for one Share upon exercise of such Share Option at an exercise price of HK\$60.02 per Share, which represents the highest of (1) the nominal value of a Share; (2) the closing price of HK\$59.00 per Share as stated in the daily quotation sheets issued by the Stock Exchange on 20 April 2018; and (3) the average closing price of HK\$60.02 per Share as stated in the daily quotation sheets issued by the Stock Exchange for the five business days immediately preceding the Date of Grant.

Subject to the provisions of the Share Option Scheme and satisfaction of vesting conditions in relation to certain performance targets as stipulated under the relevant grant letters, 3,267 Share Options and 798,016 Share Options shall vest on 1 April 2019 and 1 April 2021, respectively and will be exercisable for a period of six years after their respective vesting dates.

None of the Grantees of the Share Options is a director, chief executive or substantial shareholder of the Company, or their respective associates (as defined in the Listing Rules).
